Decision of 2 November 2017 establishing the list of French air border crossing points

The Minister of State, Minister of the Interior,
Having regard to Regulation (EU) No 2016/399 of the European Parliament and of the Council of 9 March 2016 on a Union Code on the rules governing the crossing of frontiers by persons (Schengen Borders Code);
Having regard to the Civil Aviation Code, in particular Article D. 221-5, in its wording resulting from Decree No. 2017-1490 of 24 October 2017 amending the regulatory part of the Civil Aviation Code;
Considering the decree of 24 October 2017 relating to the crossing of borders by people and goods on aerodromes, in particular Article 2;
Having regard to the opinion of the Directorate General of Customs and Indirect Tax on 2 November 2017;
Having regard to the opinion of the General Directorate of Civil Aviation dated 2 November 2017,
Decides:
